YARD MAINTENANCE REMINDER

Please make sure that you are tending to your yard on a regular basis. The grass should always be kept at a reasonable height; no more than 2-3". And although it's a great start, mowing isn't enough to keep your yard looking its best. After you mow, put the final touches on the job by using an edger around driveways, sidewalks, planter borders, trees or any other place the grass meets another surface. On a regular basis, you should remove all weeds, cut back any overgrown plant material and replace dead or dying trees/shrubbery. Lastly, don't forget to review your backyard plant material to ensure it is not encroaching into your neighbor's property.



DOGS ON LEASH

When walking or playing with your dog in the community, please remember that it should be leashed at all times. It is dangerous to let your dog roam freely. In addition, when dogs are not being supervised or on a leash they may be leaving unwanted "gifts" on your neighbor's lawn. Pet owners should refrain from allowing pets to deposit waste on anyone's private property. We ask that you please carry bags with you or obtain one from a doggie bag station in the community and remove all pet waste immediately. TRASH BIN REMINDER

Please remember to place your trash bins at the edge of the concrete gutter and avoid placing them in front of the mailboxes, as this can make it difficult for the mail delivery person to deliver the mail. Don't forget to remove the trash bins from curbside no later than Monday evening and to please store them in the garage or backyard, behind the gate, so that they are out of view of the common area.



AMERICAN FLAG PROTOCOL & ETTIQUTTE

Federal law stipulates many aspects of flag etiquette. The section of law dealing with American Flag etiquette is generally referred to as the Flag Code. Below, please find some general guidelines from the Flag Code:



- The flag should be lighted at all times, either by sunlight or by an appropriate light source.
- The flag should be flown in fair weather, unless the flag is designed for inclement weather use.
- The flag should be cleaned and mended when necessary.
- When a flag is so worn it is no longer fit to serve as a symbol of our country, it should be disposed of in the proper manner.
- Many civic associations (Boy Scouts, Veterans of Foreign Wars and the American Legion) will accept non-serviceable flags for proper disposal.
